NOTICE OF APPLICATION

Notice is given that **His Majesty the King in Right of Alberta as Represented by Agriculture and Irrigation** has filed an application under the provisions of the *Water Act* for amendment of Licence 00307271-00-00,

- to remove the suspension contingent on the addition of an exclusionary filter system to prevent Prussian Carp from being transferred to Buffalo Lake through the pumping works at the pump house located on the Red Deer River at NE-34-038-23-W4M; and

Any person who is directly affected by this application may submit a Statement of Concern within **30** days of the date of this notice.

To submit a Statement of Concern, sign into the Digital Regulatory Assurance System (DRAS) using an Alberta.ca Account or Alberta.ca Account for Organization.

Alternatively, you may submit a written Statement of Concern to Environment and Protected Areas, Approvals Unit, 5th Floor, South Petroleum Plaza, 9915 108 Street, Edmonton, Alberta T5K 2G8.

The written statement of concern should include the following:

- Quote the Case number: **DAPP0156406**
- Describe concerns that are relevant to matters regulated by the *Water Act*
- Explain how the filer of the concern will be directly affected by the diversion of water proposed in the application
- Provide the legal land location of the land owned or used by the filer where the concerns described are believed to be applicable
- State the distance between the land owned or used by the filer and the site in the application
- Contact information including the full name and mailing address of the filer. Please provide the telephone number and email address for ease of contact.

Environment and Protected Areas will review each written Statement of Concern, seek more information if needed, and notify each filer by letter of the decision to accept or reject their written submission as a valid Statement of Concern.

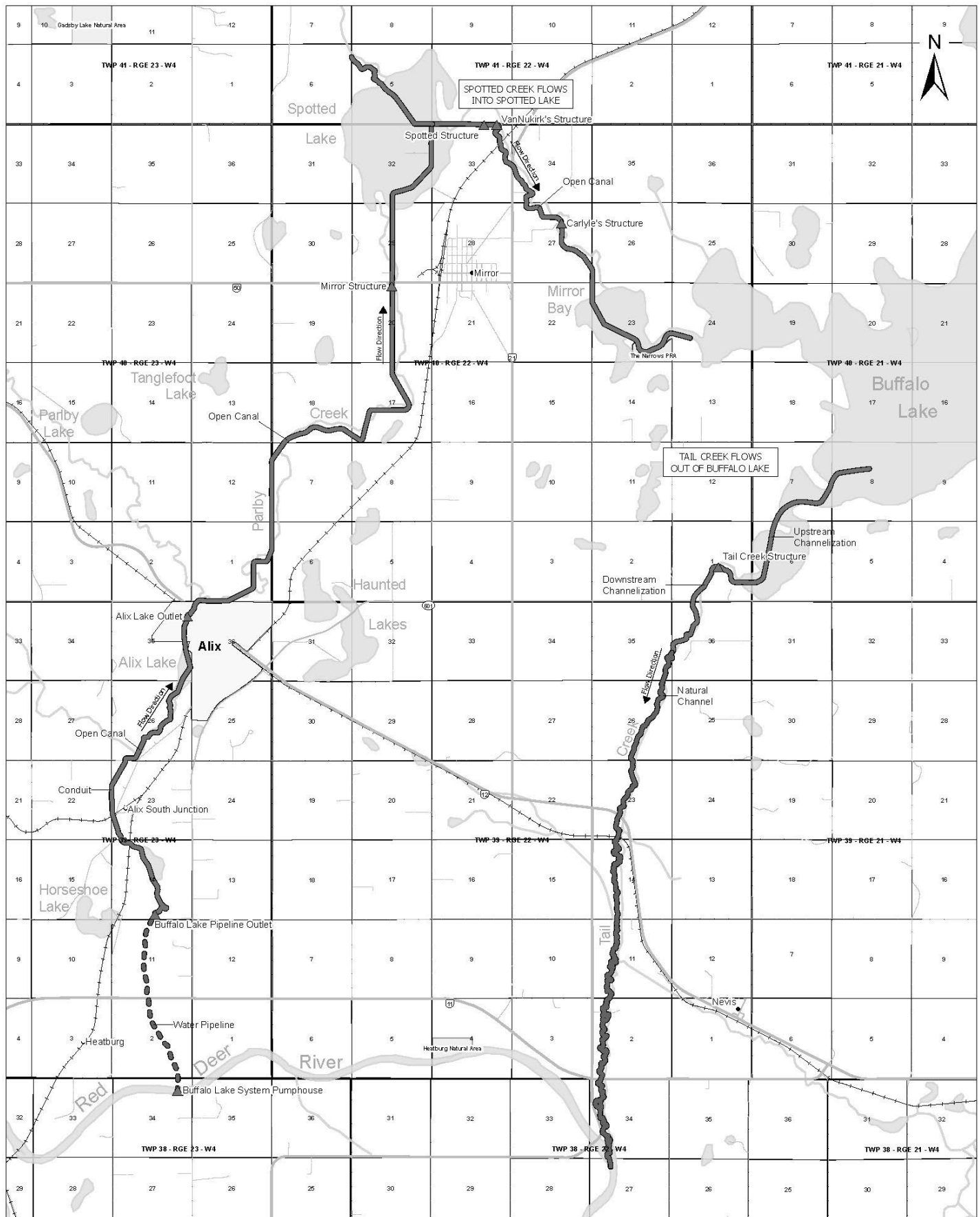
